**PLAN OF MERGER**  
**[OB Florida RRE Holdings]**

This Plan of Merger, which was adopted and approved by each party to the merger in accordance with Section 608.438, Florida Statutes, is being submitted in accordance with Section 608.4382, Florida Statutes.

1. OB Florida RRE Merging Entities. The merging entities (the "OB Florida RRE Merging Entities") are the following: (a) OB SW Florida RRE Holdings, LLC, a Florida limited liability company; (b) OB N Florida RRE Holdings, LLC, a Florida limited liability company; (c) OB SE Florida RRE Holdings, LLC, a Florida limited liability company; and (d) OB SB Florida RRE Holdings, LLC, a Florida limited liability company.

2. OB Florida RRE Surviving Entity. The surviving entity is OB Florida RRE Holdings, LLC, a Florida limited liability company (the "OB Florida RRE Surviving Entity").

3. Terms and Conditions of Merger. Upon the Effective Date, the OB Florida RRE Merging Entities shall be merged into the OB Florida RRE Surviving Entity, the separate existence of the OB Florida RRE Merging Entities shall cease, and the OB Florida RRE Surviving Entity shall continue its existence as a Florida limited liability company pursuant to the laws of the State of Florida.

4. Effect of Merger. On the Effective Date, the separate existence of the OB Florida RRE Merging Entities shall cease, and the OB Florida RRE Surviving Entity shall be fully vested in the OB Florida RRE Merging Entities' rights, privileges, immunities, powers, and franchises, subject to its restrictions, liabilities, disabilities, and duties.

5. Conversion of Interest of OB Florida RRE Merging Entities. The manner and basis of converting the outstanding interest of the OB Florida RRE Merging Entities into membership interests of the OB Florida RRE Surviving Entity are as follows: On the Effective Date, by virtue of the merger and without any action on the part of the parties or otherwise, each issued and outstanding membership interest of the OB Florida RRE Merging Entities shall be cancelled without payment of any consideration and without any conversion.

6. Articles of Organization of OB Florida RRE Surviving Entity. No amendment to the Articles of Organization of the OB Florida RRE Surviving Entity is required on account of the merger.

7. Effective Date. The merger shall become effective as of the date upon which Certificate of Merger is filed with the Secretary of State of the State of Florida (the "Effective Date").

8. Supplemental Action. If at any time after the Effective Date the OB Florida RRE Surviving Entity determines that any further conveyances, agreements, documents, instruments, and assurances, or any further action is necessary or desirable to carry out the provisions of this Plan of Merger, the appropriate officers of the OB Florida RRE Surviving Entity or the OB Florida RRE Merging Entities, as the case may be, whether past or remaining in office, shall execute and deliver, on the request of the OB Florida RRE Surviving Entity, any and all proper conveyances, agreements, documents, instruments, and assurances and perform all necessary or proper acts, to vest, perfect, confirm, or record such title thereto in the OB Florida RRE Surviving Entity, or to otherwise carry out the provisions of this Plan of Merger.


