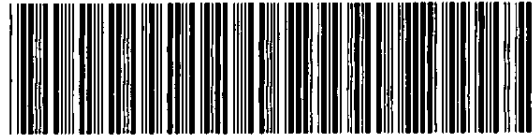

FIRST: The name and address of this Company is **THE ANTIBIOTICSHOP LLC**, 3022 San Carlos Drive, Margate, Florida 33063.

SECOND: The date of the adoption of these Articles of Dissolution is 5 July 2011.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members.
