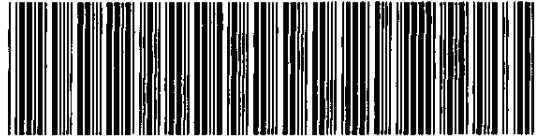

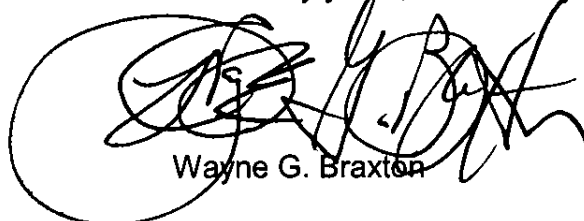

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the Laws of the State of Florida, does set forth the following:

1. NAME:

The name of the limited liability company is JULIE LANE ENTERPRISES, LLC (hereinafter referred to as the "Company").

2. PERIOD OF DURATION:

Unless earlier terminated under the Act, the period of duration of the Company shall be perpetual, beginning on the date of filing of these Articles of Organization with the Florida Department of State, Division of Corporations.

3. PURPOSE:

The purpose for which the Company is organized is to engage in any and all business and/or activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

4. ADDRESS OF PLACE OF BUSINESS:

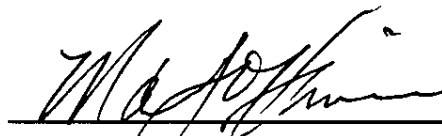

7. CONTINUITY OF BUSINESS:

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all the remaining members of the Company.

8. MANAGEMENT:

The overall management and control of the business and affairs of the Company shall be vested in its members, as provided in these Articles of Organization and Section 608.407 of the Act. Any and all action by the Company shall require the vote of members holding a majority interest in the Company.

9. NO PERSONAL LIABILITY:

The members, officers, and agents of the Company shall not be personally liable or responsible for any contracts, debts, or defaults of the Company while acting for or on behalf of the Company in any official or authorized capacity. The Company

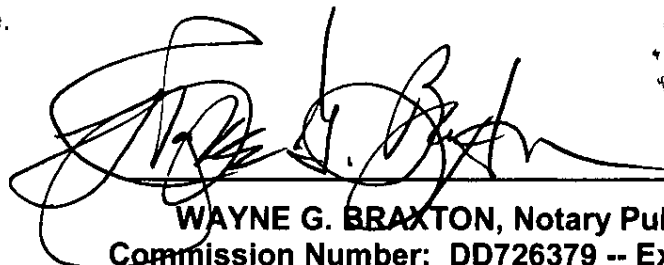
