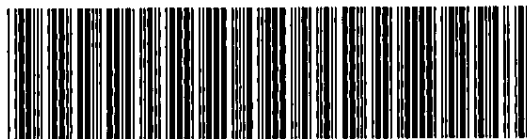

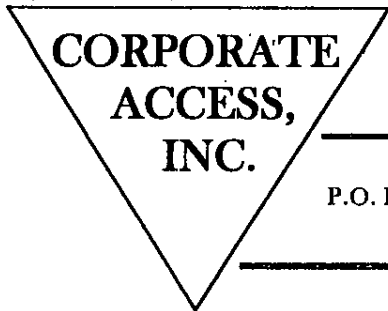

ARTICLES OF ORGANIZATION

OF

MEDICAL NEURODIAGNOSTICS & NEUROLOGY, PL, A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY

Pursuant to the provisions of Chapter 608 and Chapter 621, Florida Statutes, as amended, the following are hereby adopted and filed as the Articles of Organization of this Florida professional limited liability company:

ARTICLE I - NAME

ARTICLE III - DURATION

The Company is to commence its existence on the date of filing of these Articles by the Secretary of the State of Florida. This Company shall exist perpetually.

The number of Managers may be increased or decreased by the Members from time to time, but shall never be less than one (1). Any and all powers and duties conferred or imposed upon the Managing Member(s) and/or LLC Manager(s), in addition to those contained in Chapter 608 and Chapter 621, Florida Statutes, as amended, shall be pursuant to the provisions of the Operating Agreement of the Company or pursuant to a duly adopted resolution of the Members. ARTICLE V - PURPOSE

This professional limited liability company is organized for the following purposes:

- (a) The practice of medical neurodiagnostics; and
