The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the Limited Liability Company shall be Nova Management Group, LLC. (“company”).

ARTICLE II – ADDRESS

Effective Date 03/04/10



ARTICLE V – ADMISSION OF NEW MEMBERS

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these Articles of Organization.
