**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be: Firedog Farms, LLC.

**ARTICLE II -- ADDRESS**

The street address of the principal office is 9008 SW Highway 17, Arcadia, Florida and mailing address of this company is Post Office Box 488, Ft. Ogden, Florida 34267.

A member may transfer his or her interest in the company as set forth in the Operating Agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless a majority in interest of the members of the company, other than the member proposing to dispose of his or her interest, approve of the proposed transfer by written consent, except as otherwise provided in the Operating Agreement.

#### **ARTICLE VI -- MANAGEMENT**

The Company shall be managed by a Manager in accordance with the Operating Agreement for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization. #### **ARTICLE VII -- RESIDENT AGENT ACCEPTANCE**


