We, the undersigned, hereby execute these Articles of Organization for the purpose of organizing a limited liability company under the laws of the State of Florida.

ARTICLE I

The name of the limited liability company is Infinity Steel, LLC.

ARTICLE II

The mailing address of the limited liability company shall be 70 Barrington Drive,
