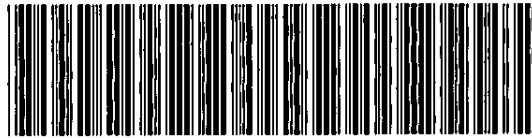

Articles of Organization
of

(A Florida limited liability company)

1. The name of this limited liability company is AZ Biscayne Holdings LLC (the "Company").

2. The Company may engage in any activity or business permitted under the laws of the State of Florida. The Company will have all of the corporate powers enumerated in the Florida Limited Liability Company Act, as amended from time to time.



The foregoing right of indemnification is not exclusive of any other rights to which any officer, employee or agent may be entitled as a matter of law or which he or she may be lawfully granted.


