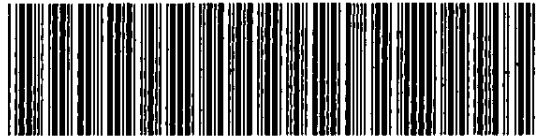

ARTICLE I - NAME

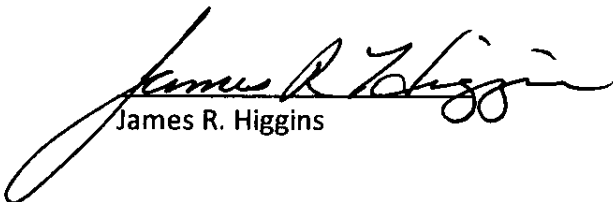
ARTICLE III - REGISTERED AGENT AND OFFICE

#### ARTICLE VIII – EFFECTIVE DATE

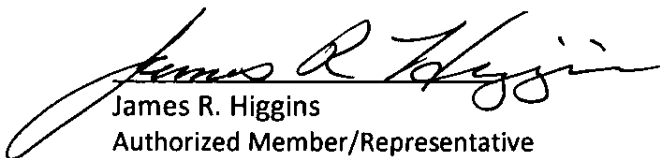

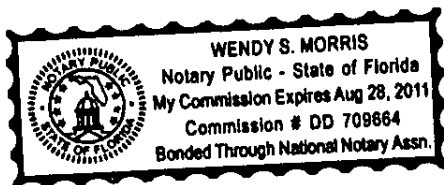

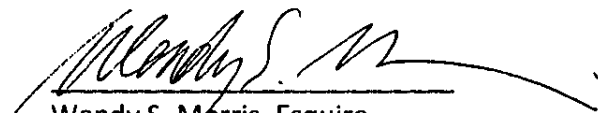
