ARTICLES OF ORGANIZATION

OF

JCIL PROPERTIES, LLC



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be JCIL PROPERTIES, LLC.

ARTICLE II -- ADDRESS
