**ARTICLE V - MANAGEMENT**

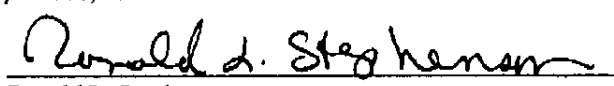
