# ARTICLES OF ORGANIZATION OF

#### SH MANAGEMENT, LLC

(A Florida Limited Liability Company)

#### ARTICLE I - NAME

The name of the limited liability company shall be SH Management, LLC (the "Company").

#### ARTICLE II - MAILING AND PRINCIPAL OFFICE ADDRESS
