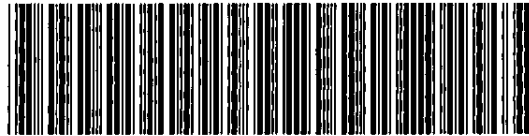

ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I: NAME AND ADDRESS

The name of the limited liability company is Thornton Realty Management, LLC. The initial mailing address and street address of the principal office of the limited liability company is 6932 Gross Avenue, West Hills, CA 91307.

ARTICLE II: PURPOSE AND POWERS

The purpose and powers of this limited liability company is to engage in any activity or business authorized under the Florida Statutes.

ARTICLE III: DURATION

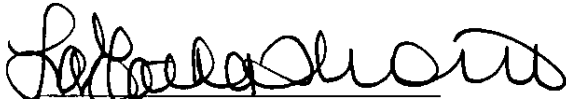
