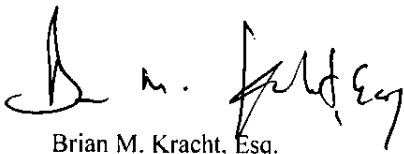

The undersigned subscribes to these Articles of Organization to form a limited liability company pursuant to the Florida Limited Liability Company Act (Chapter 608, Florida Statutes) providing for the formation, rights, privileges, and immunities of limited liability companies for profit. The undersigned further declares that the following Articles of Organization shall serve as the Charter and authority for the Company to conduct the business of the limited liability company.

ARTICLE I

**NAME**

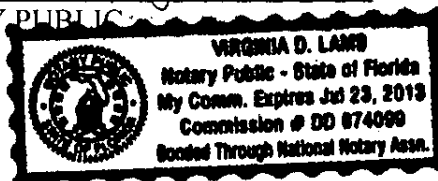
