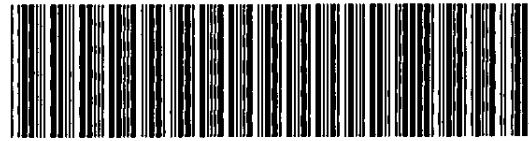

5. All debts, obligations and liabilities of the limited liability company have been paid or discharged.

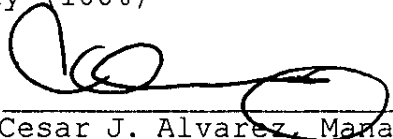
6. All remaining property and assets have been distributed to its sole Member in accordance with her respective rights and interests.
