This grant of authority shall not make the Authorized Agent a manager, or other principal of the Company and shall not subject the Authorized Agent to any liability or responsibility to any persons dealing with the Company or relying upon authority granted hereby.

The Authority granted hereby shall be effective as of the date hereof and shall remain in full force and effect until amended or cancelled as provided by law. A copy or electronically transmitted version of this document shall have the same effect as the original instrument and may be relied upon by all persons.


