ARTICLES OF ORGANIZATION

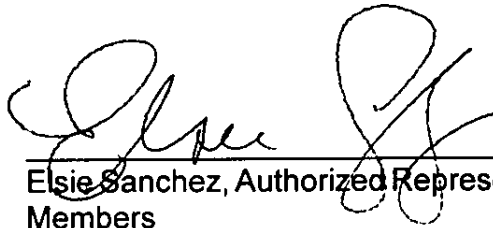

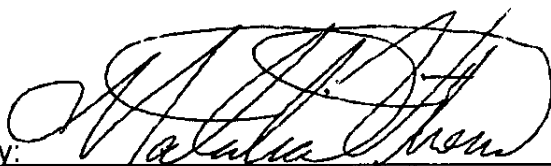
