RE: Techne, LLC; Statement of Facts

Dear Ms. McKnight:

On behalf of Techne, LLC I am submitting a signed and notarized "Statement of Facts" which we ask that you post with respect to Techne, LLC on the Department of State's website. As indicated in my correspondence to Gina McLeod of September 2, 2022 (copy enclosed) an individual named Reinaldo Bernard who has no association whatsoever with Techne, LLC is not a Member nor Manager of same, reinstated this company on March 15, 2022. Therefore, we ask that you post the Statement of Facts with respect to Techne, LLC. The applicable facts are as follows:

1. Techne, LLC was administratively dissolved in 2021.
2. On March 15, 2022 an individual named Reinaldo Bernard purported to reinstate Techne, LLC claiming he is the "CEO" of the limited liability company. In fact, Mr. Bernard is not a Member, Manager nor has any association whatsoever with Techne, LLC. Mr. Bernard listed his address as 628 NW 12th Avenue, Ft. Lauderdale, FL 33311, which is an incorrect address for Techne, LLC.
3. The reinstatement document listed Wilson M. Smith as the Manager of this limited liability company. In fact, Wilson M. Smith has no association with this limited liability company and is neither a Member nor the Manager of this limited liability company. Mr. Smith listed his address as 1774 Amaryllis Circle, Orlando, FL 32825.
4. I (Harold E. Wolfe, Jr., Esq.) am listed on the reinstatement document as the Registered Agent for this limited liability company as reinstated. There was an electronic signature

forging my signature as the registered agent for the "reinstated Techne, LLC". I am not the registered agent for Techne, LLC after it was reinstated. I am only the registered agent for the old Techne, LLC before it was administratively dissolved in 2021. My signature on the reinstatement document is an absolute forgery.

5. The Manager of the old Techne, LLC before it was administratively dissolved in 2021 is and remains Dennis W. Michaud. Mr. Michaud has no association whatsoever with either Reinaldo Bernard nor Wilson M. Smith and does not know these individuals.


6. I, Harold E. Wolfe, Jr., refuse to serve as the registered agent for the reinstated Techne, LLC which was reinstated on March 15, 2022 since my signature is a forgery on the reinstatement document.

7. On my behalf, I file this Statement of Facts to place the general public on written notice that they may dealing with individuals (i.e., Reinaldo Bernard and Wilson M. Smith) who have no association whatsoever with Techne, LLC as it existed prior to its dissolution in 2021.

By filing this Statement of Facts with the Florida Department of State we wish to place the general public on written notice of the facts contained in this Statement of Facts. I accept any responsibility whatsoever for Techne, LLC as it was reinstated after March 15, 2022. As far as we are concerned, this company was administratively dissolved in 2021 and neither Mr. Bernard nor Mr. Smith had any authority to reinstate this limited liability company.

In accordance with the Rules of the Department of State, we have submitted this Statement of Fact and had our signatures notarized as required by the Department. We ask the Department to post this letter containing the Statement of Fact as soon as possible.
