**ARTICLES OF ORGANIZATION**

**ARTICLE I**

The name of this Limited Liability Company (the "Company") is FLIGHT BASKETBALL, LLC and its mailing address is P.O. Box 621201, Orlando, Florida 32862, and the principal office address of the Company shall be located at 9183 Cardinal Meadow Trail, Orlando, Florida 32827.

**ARTICLE II**

**COMMENCEMENT OF COMPANY EXISTENCE**

This Company shall commence existence on March 1, 2010, and shall have perpetual existence unless sooner dissolved according to law.

**ARTICLE III**

**GENERAL PURPOSE: GENERAL POWERS**

The general purpose of this Company shall be the transaction of any and all lawful business. This Company shall have all of the powers enumerated in the Florida Limited Liability Company Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law. With such limitations as may be set forth in the Operating Agreement of the Company from time to time.

**ARTICLE IV**

**INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this Company shall be located at 9183 Cardinal Meadow Trail, Orlando, Florida 32827, and the initial registered agent of this Company at that address shall be Mark King. The Company may change its registered agent or

the location of its registered office, or both, from time to time without Amendment of these Articles of Organization.

## **ARTICLE V**

### **MANAGEMENT**

The Limited Liability Company is to be managed by a one or more managing members as may further be described in the Operating Agreement of the Company. The initial Managing Member shall be Mark King, 9183 Cardinal Meadow Trail, Orlando, Florida 32827.

## **ARTICLE VI**

### **REGULATIONS**

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Members.

## **ARTICLE VII**

### **MEMBERS**

The initial Members of the Limited Liability Company are: (1) Mark King, 9183 Cardinal Meadow Trail, Orlando, Florida 32827, who shall have 80% ownership interest in the Limited Liability Company; (2) Jonathan M. Mitchell, 13610 Glen Abby Drive, Charlotte, NC 28278, who shall have 10% ownership interest in the Limited Liability Company; (3) Andrew L. Haas, 4620 Longworth Drive, Orlando, Florida 32812, who shall have 5% ownership interest in the Limited Liability Company; and (d) Ernest D. Jones, 4580 Concord Landing Drive, Apt 215, Orlando, Florida 32839 who shall have 5% ownership interest in the Limited Liability Company.

Additional information regarding capital accounts, management control, voting rights, percentage ownerships and rights to receive profits and losses between the Members shall be set forth in the Operating Agreement.

## **ARTICLE VIII**

### **ADMISSION OF NEW MEMBERS**

Additional Members may be admitted from time to time on such terms and conditions as are set forth in the Operating Agreement of the Company.

## **ARTICLE IX**

### **DEATH, RETIREMENT, RESIGNATION, BANKRUPTCY, EXPULSION, DISSOLUTION OF MEMBER**

In the event of the death, retirement, resignation, bankruptcy, expulsion or dissolution of a Member or the occurrence of any event which terminates the continued Membership of a Member of the Company, the remaining Members may continue the business of the Company as provided in the Operating Agreement of the Company.

## **ARTICLE X**

### **AMENDMENT**

The Company reserves the right to amend or repeal any provisions contained in these Articles of Organization or any Amendment hereto, and any right conferred upon the Members is subject to this reservation.

## **ARTICLE XI**

### **HEADINGS AND CAPTIONS**

The headings or captions of these various Articles of Organization are inserted for convenience and none of them shall have any force or effect, and the interpretation

of the various Articles of Organization shall not be influenced by any of said headings or captions.
