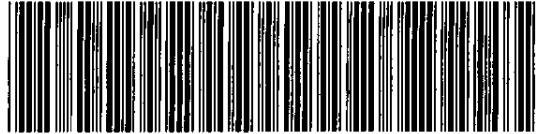



ARTICLE I - NAME

The name of this Limited Liability Company (the "Company") is JB VOLUSIA, LLC, a Florida limited liability company.

ARTICLE II - PURPOSE

ARTICLE III - DURATION


