**ARTICLE I
NAME**

The name of the limited liability company is:

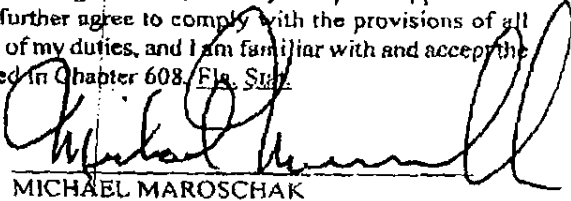
