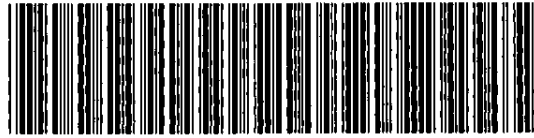

**ARTICLE I.  
NAME**

The name of the Limited Liability Company is "*Irish Acres Acquisitions, LLC*", a Florida limited liability company (the "*Company*").

**ARTICLE II.  
ADDRESS**

**ARTICLE III.  
DURATION**

MANAGEMENT**
