The undersigned organizer, who is the authorized representative of the members of COVENANT MEDIA, LLC (the "Company") under the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization.

ARTICLE I - NAME

The name of the Company is COVENANT MEDIA, LLC

ARTICLE II - DURATION

The period of duration of the Company shall be perpetual.

ARTICLE III - PRINCIPAL OFFICE

The principal place of business of the Company is 2360 St. John's Bluff Rd., #2, Jacksonville, Florida 32246.

ARTICLE VII - MANAGEMENT

The management of the Company shall be vested in the Managers. The name and address of the initial Managers is set forth in Article V. above.

ARTICLE VIII - RETURN OF CAPITAL

No member shall have the right to the return of his, her or its contribution to capital except as provided in the Company's Operating Agreement.

ARTICLE IX - AMENDMENT OF ARTICLES OF ORGANIZATION

These Articles of Organization may be amended by majority vote of the Managers of the Company as provided in Chapter 608, Florida Statutes.

ARTICLE X- OPERATING AGREEMENT

An operating agreement of this Company may be approved, adopted and amended by the members of the Company.

ARTICLE X – EFFECTIVE DATE

These Articles of Organization shall be effective as of April 1, 2010.
