The Articles of Organization of for USA4SALE MEDIA, LLC shall read as follows:

**ARTICLE I  
NAME**

The name of the limited liability company is USA4SALE Media, LLC (the "Limited Liability Company").

The member of the Limited Liability Company shall have the right to admit additional members on such terms and conditions as are provided in the Operating Agreement.


## ARTICLE VIII
