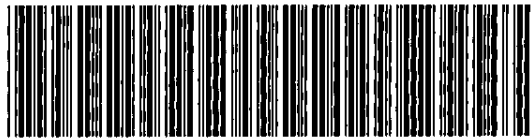

The name of the Limited Liability Company is VILLA RUSTICA 5, LLC (the "Company").


ARTICLE II - Address


