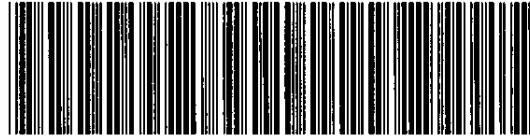



Pursuant to the provisions in Section 605.0202 of the Florida Statutes, the undersigned limited liability company hereby adopts the following Articles of Amendment to its Articles of Organization pursuant to the unanimous consent of its members:

- I. The Articles of Organization shall be amended to read as follows:

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF
NATURAL ELEMENTS PAINTING & REPAIR, LLC**

The undersigned members adopt the following Amended and Restated Articles of Organization pursuant to the provisions of the Florida Revised Limited Liability Company Act (the "Act").

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is Natural Elements Painting & Repair, LLC (the "Company").

**ARTICLE II
ORIGINAL DATE OF FILING**

The original date of filing of the Articles of Organization is March 29, 2010.

**ARTICLE III
PERIOD OF DURATION**

The Company shall have perpetual duration.

**ARTICLE IV
REGISTERED OFFICE AND AGENT**

The address of the Company's principal office and mailing address is 2510 NW 90th Terrace, Gainesville, Florida 32606. The name and address of the Company's initial registered agent in the State of Florida is **JOHN MALANCHUK**.

**ARTICLE V
REQUIREMENTS FOR ADMISSION OF ADDITIONAL MEMBERS**

Additional persons may be admitted to the Company as members and membership interests may be created and issued to these persons upon the unanimous approval of the members entitled to vote.

**ARTICLE VI
DISSOLUTION AND RIGHT TO CONTINUE BUSINESS**

The Company shall be dissolved upon the first of the following to occur:

- (a) The written consent of the Company's members representing at least two-thirds of the outstanding interest in the Company;
- (b) The death, retirement, resignation, expulsion, dissolution or bankruptcy of a member, or any other event which terminates the membership of a member in the Company, unless within ninety (90) days after such event a majority in interest of the remaining members agree in writing to continue the business of the Company.

**ARTICLE VII
MANAGEMENT**

The Company will be managed by its Manager in accordance with the Company's regulations. The name and business address of the manager is as follows:

The members reserve the right to amend, alter, change or repeal any provision herein by a majority in interest of the members of the Company.
