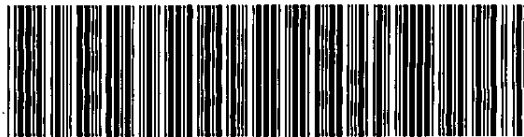

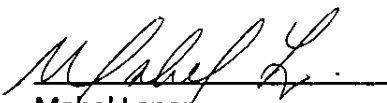

ARTICLE VIII – EFFECTIVE DATE

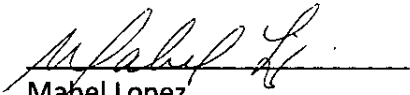

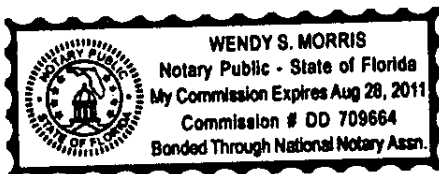

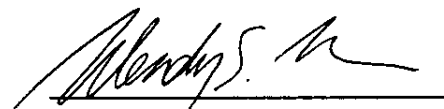
