**ARTICLES OF ORGANIZATION
OF
FLORIDA CARE, P.L.**

ARTICLE I - NAME

The name of the Professional Limited Liability Company is Florida Care, P.L. (the "Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company is 2704 John Anderson Drive, Ormond Beach, FL 32176.

ARTICLE III - PURPOSE

The general purpose for which the Company is organized is to provide medical care through licensed physician assistants, as well as any lawful act or activities necessary or incidental thereto. The professional services involved in the Company's practice of medicine in the State of Florida may be rendered only through its members, officers, agents and employees who are duly authorized and licensed to practice medicine in the State of Florida.

The Company shall not engage in any business other than providing medical care through licensed physicians assistants. However, the Company may invest its funds in real estate, mortgages, stocks, bonds and other types of investments, and may own real and personal property necessary for the rendering of the professional services authorized hereby.


ARTICLE IV - MANAGEMENT

The Company shall be manager-managed. The initial manager shall be Theresa Lessard.

ARTICLE V - INITIAL REGISTERED OFFICE & REGISTERED AGENT

The initial registered office of this Company shall be located at 2704 John Anderson Drive, Ormond Beach, FL 32176, and the name of the initial registered agent for the Company at that address is Theresa Lessard. The Company may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Organization.


