AMENDED AND RESTATED ARTICLES OF ORGANIZATION

OF

WHIPPLE PROPERTIES LLC originally filed on March 30, 2010. These articles were duly executed and are being filed in accordance with Sections 608.411 and 608.411(5) Fla. Stat.

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

1. Name.

The name of the limited liability company is WHIPPLE PROPERTIES, LLC (hereinafter referred to as the "Company").

2. Period of Duration.

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

3. Purpose.

The purpose for which the Company is organized is to engage in any and all business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

4. Address Of Place Of Business.

The mailing address for the Company is 12010 Eagle Point Ct., Leesburg, Florida 34788, and the street address of the place of business for the Company is 12010 Eagle Point Ct., Leesburg, Florida 34788. These addresses may be changed from time to time as provided in the Operating Agreement.

5. Registered Agent.

The initial registered agent in Florida for the Company is DALE M. WHIPPLE, and the initial registered office is located at 12010 Eagle Point Ct., Leesburg, Florida 34788.

6. <u>Capital Contributions</u>.

Contributions to the capital of the Company shall be made by the members, in the manner prescribed by the written Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

7. Members.

The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then-existing members, or as otherwise provided in the Operating Agreement.

8. Management.

The overall management and control of the business and affairs of the Company shall be vested in its members, as provided in these Articles of Organization and section 608.407 of the Act. Any and all action by the Company shall require the vote of members holding a majority interest in the Company.

Management of this Limited Liability Company is reserved to its Members, whose names and addresses are as follows:

DALE M. WHIPPLE, whose mailing address is 12010 Eagle Point Ct., Leesburg, Florida 34788, and whose street address is 12010 Eagle Point Ct., Leesburg, Florida 34788.

9. Continuity of Business.

Members shall have the right to admit new Members by unanimous consent. Contributions required of new Members shall be determined as of the time of admission to the Limited Liability Company.

A Member's interest in the Limited Liability Company may not be sold or otherwise transferred except with unanimous written consent of all Members.

On the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or the occurrence of any other event that terminates the continued membership of a Member in the Limited Liability Company, the remaining Member(s) shall have the right to continue the business on unanimous consent of the remaining Member(s).

10. Additional Provisions

A. <u>AMENDMENTS:</u> The power to adopt, alter, amend, or repeal the regulation of the Company is vested entirely in the Members, and requires unanimous consent thereto.

B. <u>COMPANY TO BE TREATED AS A SINGLE MEMBER UNIT ENTITY DISREGARDED FOR FEDERAL INCOME TAX PURPOSES.</u> To the fullest extent permitted by law the Company elects to be treated as a single member unit entity, so as to be disregarded for the purposes of Federal Income Tax, the income to "pass through" the Company and to be taxable to the single member unit.

11. Indemnification.

Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
