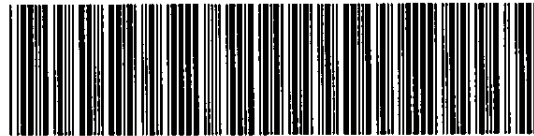

RESOLVED, that Article I of the Articles of Incorporation filed with the Secretary of State of Florida be amended as hereinafter set forth:

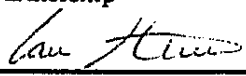
"Effective April 1, 2010, the name of this Company is
