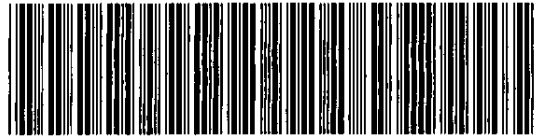



**Articles of Organization of
Gard Law Firm, PLLC**

The undersigned, acting as authorized representative of a professional limited liability company under the Florida Professional Service Corporations and Limited Liability Company Act, Chapter 621, Florida Statutes (the "Act"), files the following articles of organization for such professional limited liability company in accordance with Section 621.051 of the Act.

Article I. Name

The name of the professional limited liability company is **Gard Law Firm, PLLC**.

Article II. Duration

The period of the company's duration is perpetual.

Article III. Purposes

3.01. The professional limited liability company has the powers provided for a professional limited liability company under the Act.

3.02. The purpose for which this professional limited liability company is organized is to engage in every phase and aspect of the business of rendering the same professional services to the public that an attorney, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the State of Florida to practice law.

It is expressly hereby provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this professional limited liability company otherwise permitted by law.


