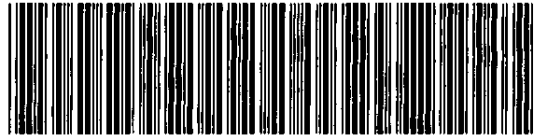

# ARTICLES OF ORGANIZATION OF LUCERO & TILLER LAW GROUP, PLLC

The undersigned, for the purpose of forming a limited liability company under the Florida Professional Limited Liability Company Act, Florida Statutes Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

## ARTICLE 1 – NAME

The name of the professional limited liability company shall be **LUCERO & TILLER LAW GROUP, PLLC** ("Company").

## ARTICLE 2 – ADDRESS

The principal place of business of the Company in Florida shall be 4400 Northcorp Parkway, Palm Beach Gardens, Florida 33410 and the mailing address shall be the same.

## ARTICLE 3 – EFFECTIVE DATE

These Articles of Organization shall be effective March 29, 2010.

## ARTICLE 4 – DURATION

Subject to the provisions of Article 8, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved as provided in these Articles of Organization.

## ARTICLE 5 – PURPOSES AND POWERS

The purpose for which the Company is organized is the practice of law. The Company shall have all powers granted to a professional limited liability company under the laws of the State of Florida.

**ARTICLE 6 – REGISTERED OFFICE AND REGISTERED AGENT**

The initial address of the registered office of this Company is 4400 Northcorp Parkway, Palm Beach Gardens, Florida 33410. The name and address of the registered agent is Donald H. Tiller III, 4400 Northcorp Parkway, Palm Beach Gardens, Florida 33410.

**ARTICLE 7 – ADMISSION OF NEW MEMBERS**

To become a member of the Company, the member must be a professional corporation, a professional limited liability company or an individual, each of which must be duly licensed or those legally authorized to render the same specific professional services as those for which the company is organized.

No additional member(s) shall be admitted to the Company except with the unanimous written consent of all member(s) of the Company and upon such terms and conditions as shall be determined by all the member(s). A member may transfer his or her interest in the Company as set forth in the regulations of the Company and in accordance with Florida Statutes, Chapter 621, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all of the other member(s) of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

**ARTICLE 8 – TERMINATION OF EXISTENCE**

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there is at least one remaining member.

**ARTICLE 9 – MANAGEMENT**

The Company shall be managed by a manager or manager(s) in accordance with regulations adopted by the member(s) for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
