



The undersigned subscribers to these Articles of Organization, each a natural person competent to contract, hereby associate themselves together to form a limited liability company under the laws of the State of Florida.

ARTICLE I. NAME

The name of this timited tiability company is:

ARTICLE II. - NATURE OF BUSINESS

The general nature of the business to be transacted by this limited liability company shall be:

- To engage and conduct in any business which is authorized and permitted by the Laws of the State of Florida, particularly the management, purchase and sale of real property.

- To acquire by purchase, subscription or otherwise and to receive, hold, own, guarantee, sell, assign, exchange, underwrite, transfer, mortgage, pledge or otherwise dispose of or deal in and with any of the unit shares, or any voting trust certificates in respect of the shares of capital stock scrip, warrants, rights, bonds, debentures notes, trust receipts, and other securities, obligations chooses in action and evidences of indebtedness or interest issued or created by any limited liability company, joint stock companies, syndicates, associations, firms, trusts, or persons public or private, or by the government of the United States of America, or by any foreign government, or by any state territory, province, municipality or other political subdivision or by any governmental agency, and as owners thereof to possess and exercise all the rights, powers and privileges or ownership including the right to execute consents and vote thereon and to do any and all acts and things necessary or advisable for the preservation, protection, improvement and enhancement in value thereof.
