SEINE LLC (A Florida Limited Liability Company)

The undersigned, desiring to form a Limited Liability Company in the State of Florida pursuant to Florida Statute, Chapter 608, hereby certifies:

ARTICLE I - NAME

The name of the limited liability company shall be SEINE LLC, hereinafter referred to as the "Company".

ARTICLE 11 - ADDRESS
