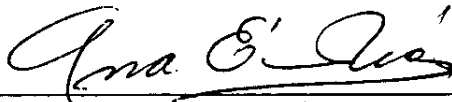

ARTICLE VI - The general nature of the business to be transacted by this corporation is:

- 1.- To provide services and act as purchasing agents for corporation or individuals in the United States and all the countries of the world.
- 2.- To export and import goods, ware, parts. machinery, vehicles, produce products and merchandise of any class.
- 3.- To represent corporations and distribute their products in the United States and other countries.
- 4.- To manufacture, purchase or otherwise acquire and to own, mortgage, pledge, sell assign, transfer or otherwise dispose of and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property and services of every class.
- 5.- To conduct business in one or more offices. Hold mortgage, sell convey, lease or otherwise dispose of real and personal property including franchises patents copyrights, trade marks and licenses in State of Florida and all other states and countries.
- 6.- To contract debts and borrow money, issue and sell or pledge bonds debentures, note and other evidences of indebtedness and execute such mortgages transfer of corporate property or other instruments to secure the payments of corporate indebtedness as required.
- 7.- To purchase the corporate assets of any other corporation and engage in the same or other character of business.
- 8.- To guarantee, endorse purchase hold sell transfer mortgage pledge or otherwise acquire or dispose of the share of the capital stock of, or any bonds , securities or other evidences or indebtedness created by an other corporation to

the state of Florida or any other state government and while owner of such stock to exercise all right to vote such stock .

9.- To carry on any lawful business necessary or incidental to the attainment of the object of this corporation whether or not such business is similar in nature to the objects enumerated in these Articles of Incorporation.

10 – To engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE VII -SHARES

The number of stock that this corporation is authorized to have outstanding at any one time shall be 1.000 share of common stock, each having \$1.00 par value all of which shall be of the same class and have the same distinguishing characteristics.

The capital stock may be paid for in property, labor or services at a just valuation to be fixed by the Directors. The stock shall be issued from time to time as may be determined by the Board of Directors.

On dissolution or liquidation of the corporation, the holders of the stock shall be entitled to distribution as their holdings may appear upon the stock record of the corporation.
