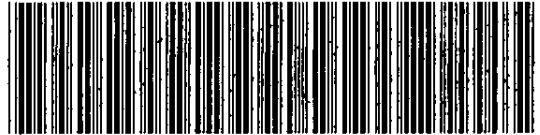

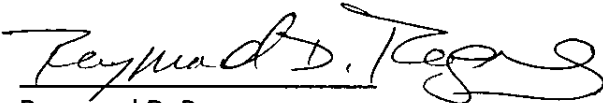

ARTICLE VIII – EFFECTIVE DATE

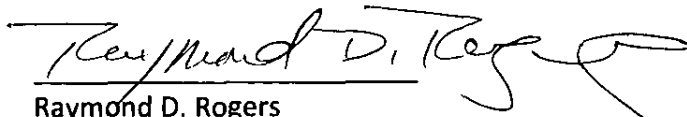
Pursuant to Section 608.409, Florida Statutes, the Limited Liability Company shall be effective as of the date that these Articles of Organization are filed with the Department of State.

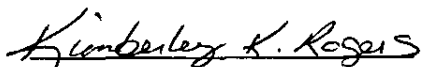
ARTICLE IX – INDEMNIFICATION

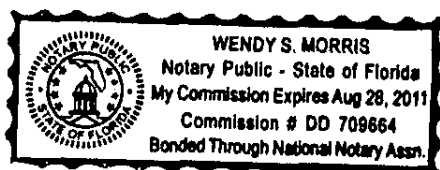
