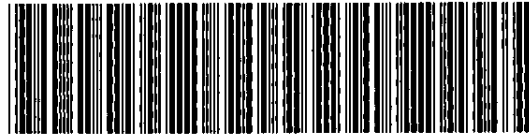

Article IV. Management

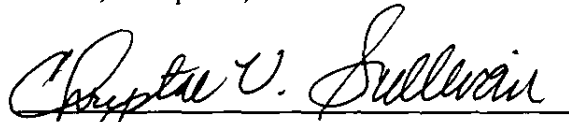
The Company shall be managed by its members.

Article V. Limitation on Agency Authority of Members

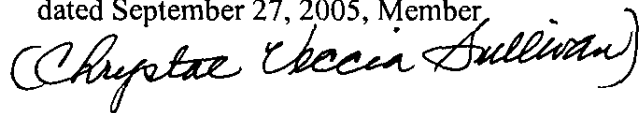
