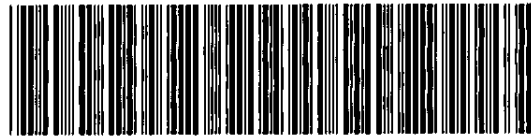

ARTICLE I

NAME

The name of the limited liability company is GREENS MARKETING GROUP, L.L.C.
(the "Company").

ARTICLE II

ADDRESS

The mailing address and street of the Company's principal office is 8899 NW 18 Street,
Doral, Florida, 33126.

ARTICLE III

PURPOSE AND POWERS

Except as restricted these Articles of Organization, this limited liability company is
organized for each and every legal and lawful purpose for which a limited liability company may
be organized pursuant to the Florida Limited Liability Company Act.

Except as restricted by these Articles of Organization, this limited liability company shall
have and may exercise all powers and rights which a limited liability company may exercise
under Florida law or the laws of the United States of America.

ARTICLE IV

DURATION

These Articles of Organization shall become effective as of the filing hereof (the
"Effective Date").

Unless earlier terminated by unanimous consent of all members, or under the Act, Fla.
Chapter 608, et seq., or the Operating Agreement, the period of duration of the Company shall be
perpetual.

ARTICLE V
REGISTERED AGENT AND OFFICE

The Name of the Company's initial registered agent is Evelyn Rodriguez. The street address of the Company's registered agent in Florida is 8899 NW 18 Street, Doral, Florida, 33126.

ARTICLE VI
AUTHORIZED REPRESENTATIVE

The name and address of the person signing these Articles of Organization as authorized representative of the members is: Evelyn Rodriguez, 8899 NW 18 Street, Doral, Florida, 33126.

ARTICLE VII
MANAGEMENT

This Company will be managed by one or more Managers appointed by the Members in accordance with the terms of the Operating Agreement. As such, the Company will be Manager-Managed. The Managers may be further designated as the President, Secretary, and Treasurer of the Company, and may also be designated as Vice Presidents, Assistant Secretaries, and Assistant Treasurers, and shall have the authority normally associated with these positions under corporate law. The Company may also designate persons as Directors under the Operating Agreement who shall act in a manner similar to the Directors of a corporation. The Members, at a meeting of the Members held not less than annually, shall designate the Managers, who shall be required to be Members, and the positions that these Managers will hold. The initial Managers, who shall serve until the first annual meeting of the Members or until their successors are elected and qualify, and their designations shall be as follows:

ARTICLE VIII

ADMISSION OF NEW MEMBERS

The then existing members of the Company shall have the right to admit new members. Additional members may be admitted only by the unanimous written consent of the existing members, and the existing member shall determine the amount and nature of contributions by new members at the time the new members are admitted.

ARTICLE IX

CONTINUATION OF BUSINESS

The remaining members of the Company may not continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member in the Company unless there is a unanimous written consent by the remaining members to do so.


ARTICLE X

ADDITIONAL PROVISIONS

A. Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.

B. The power to adopt, alter, amend, or repeal any provision contained in these Articles of Organization or the Regulations of the Company is vested entirely in the Managing Members listed above in Article VI herein, and only by written consent, in accordance with the Florida Limited Liability Company Act.

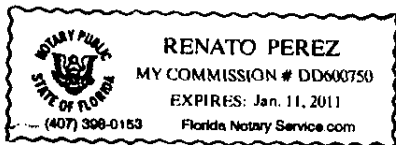


