ARTICLES OF ORGANIZATION FOR

GREENS MARKETING GROUP, L.L.C.



ARTICLE I

NAME

The name of the limited liability company is GREENS MARKETING GROUP, L.L.C. (the "Company").

ARTICLE II

ADDRESS

ARTICLE VII MANAGEMENT

This Company will be managed by one or more Managers appointed by the Members in accordance with the terms of the Operating Agreement. As such, the Company will be Manager-Managed. The Managers may be further designated as the President, Secretary, and Treasurer of the Company, and may also be designated as Vice Presidents, Assistant Secretaries, and Assistant Treasurers, and shall have the authority normally associated with these positions under corporate law. The power to adopt, alter, amend, or repeal any provision contained in these Articles of Organization or the Regulations of the Company is vested entirely in the Managing Members listed above in Article VI herein, and only by written consent, in accordance with the Florida Limited Liability Company Act.
