ARTICLES OF ORGANIZATION
OF

The undersigned hereby certifies that:

- A. He is the sole member of OUTREACH FINANCIAL SERVICES, LLC, a Florida limited liability company (the "Company").
- B. The present name of the Company, and the name under which the Company originally filed articles of organization, is OUTREACH FINANCIAL SERVICES, LLC.
- C. The date of filing of the Company's original articles of organization with the Florida Department of State was April 8, 2010.
- D. The adoption of these Amended and Restated Articles of Organization was duly authorized by the affirmative vote of the sole member who holds all of the outstanding membership units of the Company in accordance with the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (the "Act").
