- (1) Any breach of his or her duty of loyalty to the Limited Liability Company, or to its members;
- (2) An act or omission that was taken in bad faith and which constitutes a breach of the manager's duty to the Limited Liability Company by an act that is grossly negligent, malicious, or intentional, as those terms are defined at law;
- (3) A transaction in which the manager benefits to the detriment of the company or its members.
- (4) An action for which the manager is liable at law and for which an indemnification

is not allowed.


**ARTICLE VIII**


