THIRD: Article IV and V are hereby amended to read:

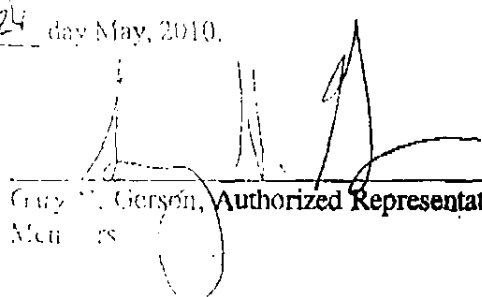
**ARTICLE IV
