ARTICLES OF ORGANIZATION

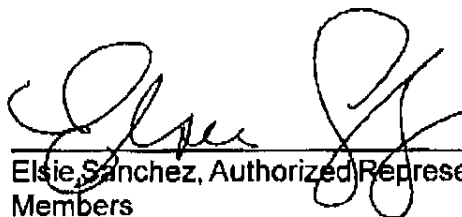

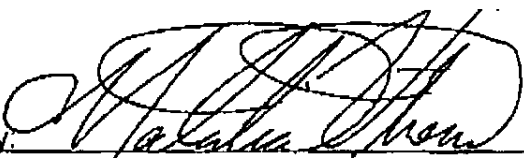
