ARTICLE VIII - RESTRICTION ON MEMBERSHIP

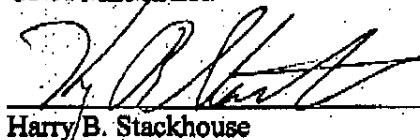
