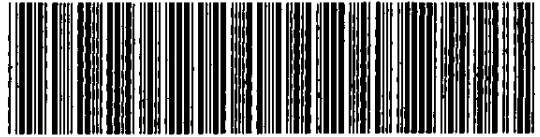





PURPOSE


