The undersigned files these Articles of Organization in order to form a limited liability company pursuant to Florida Statute 608.407.

**ARTICLE I**

The name of the limited liability company shall be MEDIATION SUPPORT SERVICES, LLC.

**ARTICLE II**

The limited liability company shall exist perpetually.

**ARTICLE III**

The mailing address of the limited liability company is 2701 Southeast Maricamp Road, Suite 104, Ocala, Florida 34471. The street address of the principal office of the limited liability company shall be 7500 Southwest 61<sup>st</sup> Avenue, Unit 7, Ocala, Florida 34476.

**ARTICLE IV**
