Pursuant to the applicable provisions of Section 18-209 of the Delaware Limited Liability Company Act and Sections 605.1021-605.1026 of the Florida Revised Limited Liability Company Act, the undersigned, desiring to effect a merger (the "**Merger**"), hereby state as follows this 28th day of February 2020:

FIRST: The exact name, entity type, and jurisdiction for each merging party are as follows:

Merging Company: HRNX LLC, a Delaware limited liability company.

Surviving Company: Cloudmills LLC, a Florida limited liability company.

SECOND: The name of the Surviving Company in the Merger is hereby amended and changed to:

"Cloudmills HRNX LLC"

THIRD: The Merger shall become effective on February 29, 2020.

FOURTH: The Merger has been duly approved, adopted and executed and acknowledged by the Surviving Company pursuant to Sections 605.1021 to 605.1026 of the Florida Revised Limited Liability Company Act; by the Merging Company pursuant to Chapter 18 of the Delaware Limited Liability Company Act; and by each member of such limited liability companies who as a result of the merger will have interest holder liability under Section 605.1023(1)(b) of the Florida Revised Limited Liability Company Act.

FIFTH: The Surviving Company agrees to pay any members with appraisal rights the amount to which such members are entitled under Sections 605.1006 and 605.1061-605.1072 of the Florida Revised Limited Liability Company Act;
