FINAL JUDGMENT OF CHANGE OF NAME



4. Granting this petition will not in any manner invade the property rights of others, whether partnership, patent, good will, privacy, trademark, or otherwise; it is



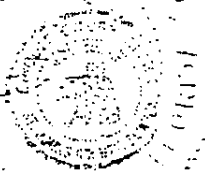
