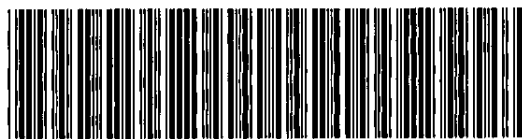

Principal Office




