ARTICLES OF ORGANIZATION

OF

RESORT MAINTENANCE SERVICES, LLC

Pursuant to the provisions of Chapter 608, Florida Statutes, the undersigned being authorized to execute and file these Articles, adopts the following Limited Liability Company Articles of Organization:

ARTICLE I - NAME

The name of this Limited Liability Company is **RESORT MAINTENANCE SERVICES, LLC**.

ARTICLE II - MAILING ADDRESS AND STREET ADDRESS

ARTICLE III - PURPOSE

However, the transferee or assignee shall not be entitled to become a member or participate in the business and affairs of this limited company unless the transfer or assignment is approved by the unanimous consent of the member(s) not proposing to transfer or assign their interests.

These Articles of Organization and the Company's Operating Agreement may be amended at any time by the members.


